Dear Members and Friends of the CFNA Rocky Mountain chapter. Welcome to the New Year!

The 2020 CFNA Rocky Mountain chapter test and seminar will take place Friday through Sunday March 28-30.

The **Seminar** will be held on Friday, March 28 from 8:00 a.m. to 5:30 p.m. Robert Milner, author of [Absolutely Positively Gun Dog Training](#) will be the speaker. He will be condensing his two-day seminar into a 1-day program for our club. Attendees will learn valuable techniques for cooperative training to develop your dog into a skilled hunter and family companion. There will be a 1-hour lunch break with a catered lunch (taco bar) available at that time. The cost of the seminar with lunch is \$25.00. **This fee needs to be prepaid as a reservation for your attendance at the seminar and lunch. Use included Rocky Mountain payment form.**

On Thursday, March 27, there will be a **puppy exposure/ pre-test training event** at the test grounds, for those interested. The exposure day is to give handlers and dogs some additional help/training/acclimation to the test site/water work/bird contact prior to the test. It is an opportunity for members that have no access to open water for months before the test or have a dog that needs a brush up on tracking or duck work, to practice one more time. This pretest training day costs \$10.00. Birds and one-on-one help will be available to handlers.

For those individuals that may be entering a dog for the Idaho test, I have included a test entry and payment forms. These forms are also available on our website www.ceskyfousekna.org. Please e-mail or mail your forms back to me as soon as possible so that sufficient birds are available for testing and scorecards, running orders, meals, volunteers, etc. are all lined up and ready for the event. My e-mail and mailing address are located at the bottom of this letter.

Test booklets, for those who have not run a dog in a test before or have lost previous copies, are available on request or can be obtained from our website. (see above).

You must submit any and all registration forms and payments to me no later than February 28, 2020. Submitting the registration information on time ensures that you and your dog will have a place in our test. Timely registration also helps out the volunteers that make our test run (record keeping, bird purchasing, food, etc.) Thank you for your understanding and we look forward to seeing you at the spring test.

If you have not done so previously, via PayPal on our website (www.ceskyfousekna.org), it is also that time of year for RMGC chapter members to **mail in your dues of \$10 per household.** Thank you in advance for supporting our club.

ALL ENTRIES CLOSE FEBRUARY 28, 2020

Dogs are eligible for the Natural Ability Test from the age of 6 months up until and including the day they reach 16 months of age. Dogs over 16 months of age may be entered for evaluation only. Dogs from 16 months to 24 months are eligible for the Intermediate Test. Overage dogs are entered under the special category of Older Hunting Dog and are judged more severely in obedience. Dogs 18 months and older are eligible for the Utility Field Test. Registered dogs other than Cesky Fouseks are eligible and welcome for all tests. Test rules will be sent to each entry.

Driving Directions:

Coming from Boise you will travel East on I-84 until you reach exit 173. At the bottom of the exit you will turn left heading north until you reach a cross section of Highway 93. You will notice a flying J gas station on your right - hand side. Our property is located on the left - hand side at 379 Crossroads Point Blvd. Coming from Salt Lake City Utah you will travel on I-84 going North. You will need to take exit 173. At the stop sign you will turn right. This is Highway 93. Take left on Crossroads Point Blvd until you reach the Comfort Inn and Suites. We are located off the Twin Falls Exit 173. We are approximately 3 miles from Twin Falls.

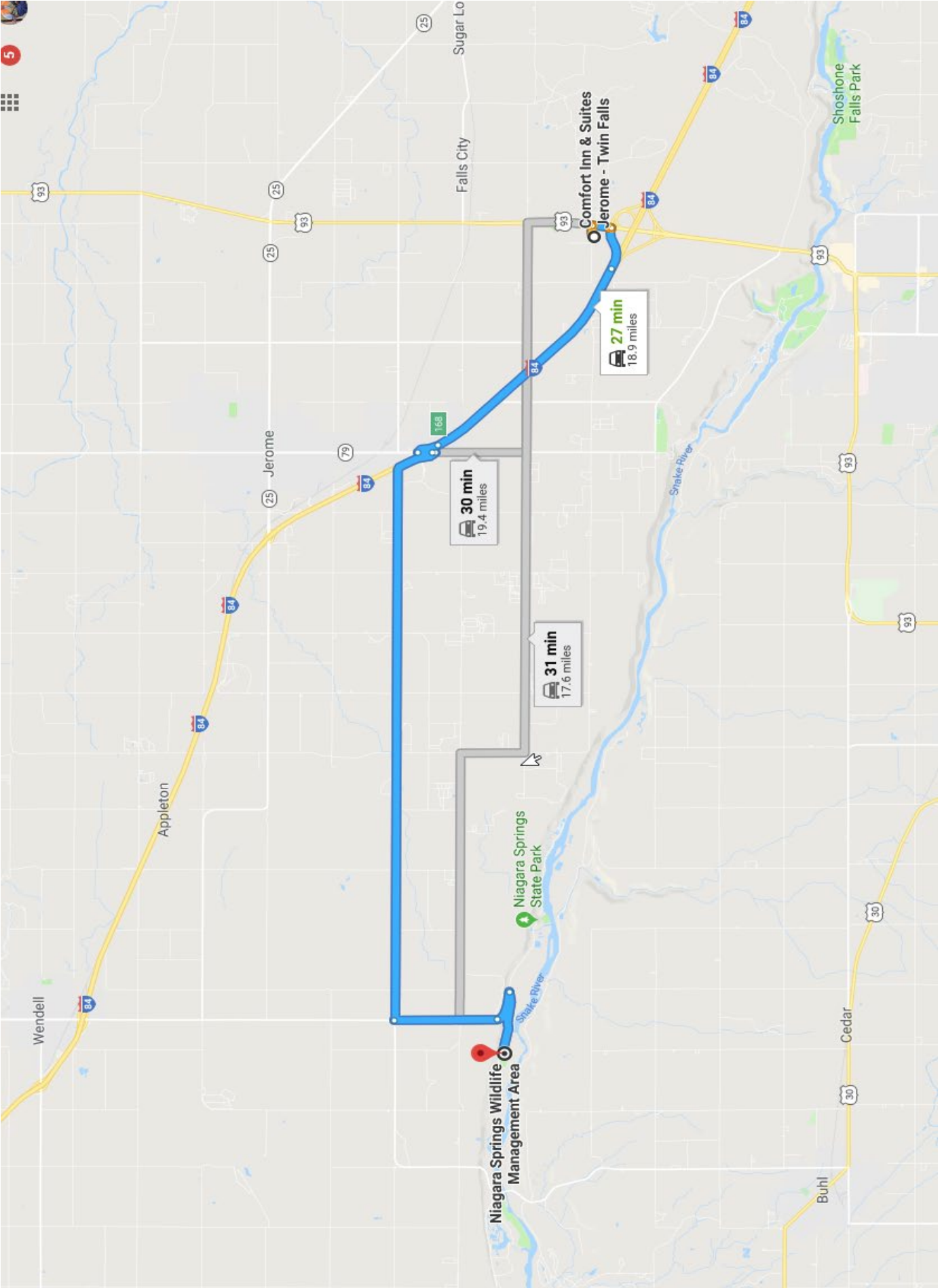

Start out going east on Crossroads Point Blvd toward Arlen Dr.

0.17 miles



Take the 2nd right onto US Highway 93/US-93 S.

0.30 miles

- *US Highway 93 is 0.1 miles past Arlen Dr*
- *If you reach Crossroads Pkwy you've gone about 0.2 miles too far*



Merge onto I-84 W toward Boise.

4.74 miles



Take the ID-79 exit, EXIT 168, toward Jerome.

0.38 miles



Turn left onto S Lincoln Ave/ID-79.

0.27 miles



Turn right onto Bob Barton Rd.

5.39 miles

- *If you are on Golf Course Rd and reach E Frontage Rd S you've gone a little too far*



Bob Barton Rd becomes Bob Barton Hwy.

4.46 miles



Turn left onto S 1950 E.

1.60 miles

- *S 1950 E is 0.5 miles past S 2000 E*
- *If you reach S 1950 E you've gone a little too far*



S 1950 E becomes Niagra Springs Rd (Portions unpaved and steep).
